Your 2021 Annual Water Quality Report

The City of Gregory Water is providing this annual Drinking Water Quality Report to tell you about the quality of the water and how it compares to the guidelines set by the U.S. Environmental Protection Agency (EPA). All drinking water providers are required by federal law to issue annual quality reports like this one to their customers.

Most importantly, we want you to know that when you drink tap water from our system, you are drinking clean high-quality water that meets strict government standards. This report will help you understand the steps taken every day by our experienced staff to deliver the safe drinking water that is essential to human survival.

Many people are surprised to learn that all drinking water, even bottled water, is likely to contain some level of contaminants. The presence of contaminants does not necessarily mean that the water poses a health risk. Many constituents (such as calcium sodium or iron), which are often found in drinking water, can cause taste color and odor problems. These are known as secondary constituents, and they are regulated by the State of Texas, not the EPA. These constituents are not necessarily causes for health concern. Therefore, they are not required to be reported in this document, but they may affect the appearance and taste of your water.

Health Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water comes primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high quality drinking water, but we cannot control the variety of materials used in plumbing components. If your water has been sitting for several hours, you can minimize the potential lead exposure by flushing your tap for 30 seconds to 2 minutes before drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. The TCEQ completed an assessment of your source water and results indicate that some of your sources are susceptible to certain contaminants. The sampling requirements for your water system are based on this susceptibility and previous sample data. The Lead and Copper Rule protects public health by minimizing lead and copper levels in drinking water, primarily by reducing water corrosion. Sources of Drinking Water

The sources of drinking water is surface water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPAs Safe Drinking Water Hotline at (800) 426-4791.

Contaminants that may be present include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife
- Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential use
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production and can also come from gas stations, urban storm water runoff, and septic systems
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which must provide the same protection for public health. You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly, or immunocompromised persons, such as those undergoing chemotherapy for cancer; persons who have undergone organ transplants; those who are undergoing treatment with steroids: and people with HIV/AIDS or other immune system disorders can particularly be at risk from infections. You should seek advice about drinking water from your physician or health care provider. To protect public health, the EPA has identified acceptable level for constituents in tap water. The TCEQ has assessed out water system and determined that our water is safe to drink. All constituents in our water are well below the federal and state maximum containment levels. Nitrate Advisory – Nitrate is drinking water at level above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Definitions

Action Level Goal (ALG): The level of a contaminant in drinking water below which there is no known or expected risk to health (ALGs allow for a margin of safety)

Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements

Avg: Regulatory compliance with some MCLs is based on running annual average or monthly samples that are taken

Maximum Contaminant Level or (MCL): The highest level of a contaminant that is allowed in drinking water and are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal or (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health (MCLGs allow for a margin of safety)

Maximum Residual Disinfectant Level or (MRDL): The highest level of a disinfectant allowed in drinking water and there is evidence that addition of a disinfectant is necessary for control of microbial contaminants

Maximum Residual Disinfectant Level Goal or (MRDLG): The level of a drinking water disinfectant below, which there is no known or expected risk to health (MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants)
