Notice is hereby given that the governing Body of the City of Gregory, Texas will hold a Special Called Meeting in the **27th day of September, 2025, at 8:00 a.m.** in the Council Chambers of the Gregory City Hall located at 310 Ayers St., Gregory, Texas. Pursuant to Texas government Code Section 551.127, a member of the City Council intends to participate in this meeting by videoconference call. A quorum of the City Council and the Councilmember presiding over the meeting shall be present at the location stated above, and said location shall be open to the public during all open portions of the meeting. An audio recording will be made of this meeting, and be available to the public.

The public will be permitted to offer public comments as provided by the agenda and as permitted by the presiding officer during the meeting. Should there be more than five (5) persons to speak on a particular issue, they need to select one (1) representative to speak. Your presentation will be limited to three (3) minutes. Written comments may be submitted to City Secretary norma.garcia@gregory-tx.com up to two hours before the meeting. An audio recording of meeting will be made and will be available to the public in accordance with the Texas Public Information Act upon written request.

Please be advised that the open meetings act prohibits the city council from responding and discussing your comments at length. The law only authorizes them to do the following:

- Make a statement of factual information.
- Recite an existing policy in response to the inquiry.
- Advise the citizen that this subject will be placed on an agenda at a later date.

No council member, staff person, or members of the audience shall berate, embarrass, accuse, or show any personal disrespect for any member of the staff, council members, or the public at any council meeting. This policy is not meant to restrain a citizen's first amendment rights.

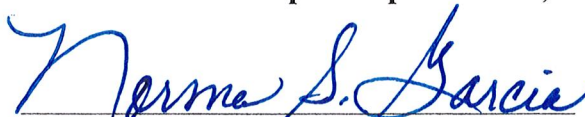

This provision has been added to this agenda with the intent to meet all elements necessary to satisfy Texas Government Code Chapter 551.144(c) and the meeting is conducted by all participants in reliance on this opinion

Attendance by Other Elected or Appointed Officials: It is anticipated that members of the other city boards, commissions and/or committees may attend the meeting in numbers that may constitute a quorum of the other city boards, commissions and/or committees. Notice is hereby given that the meeting, to the extent required by law, is also noticed as a meeting of the City Council, other boards, commissions and/or committees of the City, whose members may be in attendance. The members of the boards, commissions and/or committees may participate in discussions on the same items listed on the agenda, which occur at the meeting, but no action will be taken by such in attendance unless such item and action are specifically provided for on an agenda for that board, commission or committee subject to the Texas Open Meetings Act.
