ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF GREGORY, BEING ORDINANCE NO. 10-05-2013, AS AMENDED, CODIFIED AS APPENDIX “A” OF THE CODE OF THE CITY OF GREGORY, BY AMENDING ARTICLE I CHAPTER A. (e) “TOW TRUCKS AND NON CONSENT TOWS”, TO AMEND ARTICLE IV CHAPTER H. 1. “MAXIMUM DISTANCE OF POLICE OR NON-CONSENT TOWS”; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A FINE OR PENALTY OF THIS ORDINANCE AS A MISDEMEANOR SUBJECT TO A FINE NOT TO EXCEED FIVE HUNDRED DOLLARS (\$550.00) FOR EACH OFFENSE, EXCEPT HOWEVER, WHERE A DIFFERENT PENALTY HAS BEEN ESTABLISHED BY STATE LAW FOR SUCH OFFENSE, IN WHICH EVENT THE PENALTY SHALL BE FIXED BY STATE LAW AND IF, DEEMED A VIOLATION OF ANY PROVISIONAL LAW THAT GOVERNS FIRE SAFETY, ZONING, OR PUBLIC HEALTH AND SANITATION, THE PENALTY SHALL NOT EXCEED THE SUMS OF TWO THOUSAND DOLLARS (\$2,000.00) FOR EACH OFFENSE; AND PROVIDING A SAVINGS CLAUSE.
