a) **Minutes of April 4, 2022** - Alderman Flores made the motion to approve minutes of April 4, 2022 and motion was voted with all ayes and 0 nays.

### ACTION ITEMS

a) **Consideration with possible action for the approval to advertise for the position of a Grant Administrator** – In the past the city has used GrantWorks and other grant administrators to apply for grants. We are now in the position to hire an administrator to submit and administer grant applications on behalf of the city. This person’s fees would be funded through the grant administrative fee. Motion was made by Alderman Flores to advertise for the position of grant writer and seconded by Alderman Lopez. Motion carried with all ayes and 0 nays.

b) **Consideration with possible action to approve Resolution 2022-04-01 A RESOLUTION OF THE CITY OF GREGORY, TEXAS FINDING THAT AEP TEXAS INC.’S APPLICATION TO AMEND ITS DISTRIBUTION COST RECOVERY FACTORS TO INCREASE DISTRIBUTION RATES WITHIN THE CITY SHOULD BE DENIED; AUTHORIZING PARTICIPATION WITH THE CITIES SERVED BY AEP TEXAS; AUTHORIZING HIRING OF LEGAL COUNSEL; FINDING THAT THE CITY’S REASONABLE RATE CASE EXPENSES SHALL BE REIMBURSED BY THE COMPANY; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; REQUIRING NOTICE OF THIS RESOLUTION TO THE COMPANY AND LEGAL COUNSEL** – Motion was made by Alderman Lopez to approve Resolution 2022-04-01 and seconded by Alderman Flores. Motion carried with all ayes and 0 nays.

c) **Consideration with possible action to approve amended Professional Service Agreement with Ardurra for the City of Gregory Critical Facility Generators GLO Contract No 20-065-114-C313 for additional \$5,000.00** - Council had approved the payment for the Environmental Assessment that had not been budgeted in the grant. Special Counsel had recommended to amend the contract to include the new dollar amount for the environmental review. Motion was made by Alderman Martinez to approve the amended contract to include the additional amount of \$5,000.00. Motion was seconded by Alderman Hernandez and it carried with all ayes and 0 nays.

- d) Consideration with possible action to approve Recommendation of Award - Oasis Waterplaygrounds, Inc., for Splash Pad Project with base bid of \$195,000.00** – Alderman Martinez made the motion to table the discussion to review the specifications and look into the Cheniere Logo. Motion was seconded by Alderman Flores and it carried with all ayes and 0 nays.
- e) Consideration with possible action to approve Recommendation of Award – G-8 Utilities, LLC for Critical Facility Generators GLO Contract No 20-065-114-C313 with base bid \$72,000.00 + Additive Alternative No. 17,500.00 total amount \$89,500.00** – This is for the emergency generators at main lift stations located at North & Liberty Streets and Orchid Circle Housing Authority. Motion was made by Alderman Martinez to award bid and seconded by Alderman Lopez. Motion carried with all ayes and 0 nays.
- f) Consideration with possible action to approve ORDINANCE 2022-05-01 AN ORDINANCE OF THE CITY OF GREGORY, TEXAS, APPROVING A BUDGET AMENDMENT, PROVIDING FOR SEVERABILITY, REPEALING ALL ORDINANCES IN CONFLICT AND ESTABLISHING AN EFFECTIVE DATE** – budget is being amended to fund Capital Projects and create bank accounts for this particular purpose. We have two capital projects going and will be needing funds. They are the Colima Street Expansion and Splash Pad. Generators will be needed for the new complex and water plant also. There will be no impact on the interest and sinking and capital improvement funds. Motion was made by Alderman Flores to approve the amendment and seconded by Alderman Lopez. Motion carried with all ayes and 0 nays.
- g) Discussion with possible action to approve Gregory’s Second Annual Patriotic Parade/Day for September 10, 2022** – Mr. Gilbert Cortinas was not able to make the meeting. All that is needed is permission to get an early start. Motion was made Alderman Flores to approve the parade and was seconded by Alderman Lopez. Motion carried with all ayes and 0 nays.
- h) Consideration with possible action to appoint Mr. Kevin Hendryx as Board member to the Gregory Economic Development Board 4B** – Mr. Hendryx has help with our city activities so I reached out to him and he accepted to fill the position. We are needing to get this committee going and if Mr. Solis and Mr. Martinez accept we will have six members to move forward, said City Administrator Cano. Motion was made by Alderman Flores and seconded by Alderman Lopez. Motion carried with all ayes and 0 nays. Mayor Garcia administered oath to Mr. Hendryx.
