COMMENTS FROM AUDIENCE – NONE PUBLICL HEARINGS – NONE CONSENT AGENDA –

1) Approval of Minutes of May 3, 2021 – Motion was made by Mayor Pro-Tem Reyes to approve minutes of May 3, 2021.

### PRESENTATIONS -

- a) Presentation b Ms. Kara Rivas for Phillips 66 and Bluewater Texas Terminal Project- Ms. Rivas told members Mayor Garcia and Mayor Pro-Tem Reyes had met with Mr. Rich Johnson earlier and would like to give the council members a brief presentation of what was discussed. Ms. Jill Sweeney gave members a presentation. She told them of the project which is a joint venture between Trafigura and Phillips 66 for an offshore deep water port. This would have a pipe line from Taft to Port Aransas along Hwy 136 to Harbor Island we already have an agreement with Port of Corpus Christi Authority to create an operation facility. Boring will be done at Red Fish Bay as to not disturb the environment. Alderman Martinez asked about the construction on shore and was told it would be a 30" pipe encased for protection.
- b) Update for the Municipal Complex by Mrs. Brannyn McDougal Mrs. McDougal told members Bids came in May 13<sup>th</sup> and in a couple of weeks we will be getting the contractor. Alderman Martinez asked when they will award and was told by August 1<sup>st</sup>, but I'm not be able to give you notice for the ground breaking any time soon.

## **ACTION ITEMS**

- a) Presentation and discussion of Plan of Finance for the issuance of General Obligation Refunding Bond, Series 2021– Mr. Andre Ayala gave presentation and discussion about the bond obligation that the city currently holds. Mr. Ayala said this is the time to refinance the debt for a lower interest rate from what is currently being paid of 5.04%. He gave members a schedule of the process from the taking of bids by June 4<sup>th</sup> and by June 7<sup>th</sup> to consider and lock interest and close by July 6<sup>th</sup>. Mr. Ayala was given the okay to proceed with the plan of finance for the issuance of General Obligation Refunding to give us a lower interest rate.
- b) Resolution 2021-05-03: A Resolution Appointing the Law Firm of McCall Parkhurst & Horton to Provide Legal Services as Bond Counsel Mr. Noel Valdez made his presentation to council. He currently works locally with the cities of Victoria, Robstown and Alice. We work in sale of bonds and Alderman Martinez asked about the fee. Mr. Valdez told him we do not charge a fee until the bond is

sold and it is funded through the sale. Mayor Pro-Tem Reyes questioned the amount of fee and was told it is usually about \$12,000 if there is a sale. Motion was made by Mayor Pro-Tem Reyes to approve Resolution 2021-05-03 to appoint the Law Firm and seconded by Alderman Martinez. Motion carried with all ayes and 0 nays.

c) Presentation on proposed Somerset Development related to financing and terms of Development agreement and provide direction to city staff and consultants – Mr. Wiley McIlwain presented to Council his proposed development. It will a 300 lot subdivision with single family dwellings. This will be located in 67 acres adjacent to the school and there will be approx. 5 acres for commercial along Hwy 35. We are wanting to change the location for the construction of the lift station. Andre assisted and said they can be financed with bond sales and share tax increment on the value of property. Within 4-5 years there will be an increase in values and raise tax values. The lots will sell in the high 30's and homes \$230,000-240,000. All this is based on the wastewater flow to plant. Alderman Martinez said this would mean more staff, more services and potential commercial that will come within the next 2-3 years. This is the most visible piece of property along Hwy 35, FM 361 and FM 136.
