PRESENTATIONS

- a) **Update on the Municipal Complex by Mrs. Brannyn McDougal** Mrs. McDougal gave members an update as to progress of the project. Contractor will be moving equipment by July 26 and will be hosting ground breaking event scheduled for July 28, 2021. Will be emailing invitation. Construction schedule will be for approx. 16 months.
- b) Update on the Somerset Development and closing of General Obligation Refunding Bonds, Series 2021 presentation by Mr. Andre Ayala and Mr. Noel Valdez Andre told members he hadn't heard from Mr. McIlwain. I will come back for the next meeting with some numbers for Phase I of the project with 350 homes and the levy of assessment to be paid by homeowners. On the closing of the General bond we need to discuss how to use the revenues for a future sewer plant or renovation. Will need to discuss financial planning but will need more data.
- c) Discuss of a possible 9-11 parade presentation by Mr. Gilbert Cortinas and Chief Cano Mr. Cortinas made the presentation to Council about hosting a 911 parade here in the city to honor all veterans and commemorate 911. G-PISD will hold a honk pep rally. This would be a patriotic rally and we have persons ready to participate and assist with the anticipation of bring the two communities together. We will be going to the industries to assist and bring them onboard to participate.

ACTION ITEMS


