**PUBLIC HEARING -**

**PRESENTATIONS** – Update presentation by Dr. Michelle Cavazos for the Gregory-Portland Independent School District – Dr. Cavazos introduced Mr. Ismael Gonzales III and Ms. Cary Gregory who were also present representing the district. She spoke of their master planning for the next ten (10) years, which included building, programing etc. She also told them of the upcoming bond election which will be held November 8, 2022. If bond should pass, there will be no tax increase. Eighty-nine (89%) of the funding would come from the industries and 11% from the levy of ad valorem tax. Tax rate would remain at \$1.2103 per hundred valuation.

**CONSENT AGENDA** – Minutes of September 19, 2022 – Mayor Pro-Tem Flores made the motion to approve minutes with correction to change last name from Flores to Martinez for Alderman Pablo Martinez. It carried with all ayes and 0 nays.

## **ACTION ITEMS**

- a) Consideration with possible action to approve City of Gregory Audit for fiscal year 2020-2021, presentation by Mr. Noel Snedeker Mr. Snedeker gave presentation to council members. He explained the opinion letter and the analysis with it's highlights. As of September 30, 2021, the city had a combined ending balance of \$3,304,040 and a net position of \$9,705,369. He made the recommendation to move to INCODE and eliminate QuickBooks. The City has outgrown that program. Mayor Pro-Tem Flores made the motion to approve audit report and seconded by Alderman Smith. Motion carried with all ayes and 0 nays.
- **b)** Consideration with possible action to approve Holiday Schedule for 2022-2023 Motion was made by Alderman Boyes to approve the schedule as presented. Motion was seconded by Alderman Hernandez and it carried with all ayes and 0 nay.
